**Announcement regarding Deltic Energy plc**

Following a recent movement in the Company's share price, the Company has announced that it is currently in discussions with three parties, being (i) Capricorn Energy PLC; (ii) Petrogas International E&P Coöperatief U.A., a subsidiary of Mohammed Al Barwani LLC; and (iii) Blue Concept Hld AS, a private Norwegian company, which have each separately approached the Company regarding possible cash offers for the entire issued and to be issued ordinary share capital of the Company ("**Possible Offer**"), which may or may not result in a formal offer.

The purpose of this email is to give you notice, in accordance with Rule 2.11 of the City Code on Takeovers and Mergers (the "**Code**"), that a copy of the announcement dated 22 April 2026 as amended today, made by the Company (the "**Announcement**") has been published on the Company's website at <https://delticenergy.com/disclaimer/>.

Although the Announcement has put the Company into an "offer period" under the Code, there can be no certainty that a firm offer for the Company will be made, nor as to the terms of any firm offer (if made).

If an announcement of a firm intention to make an offer is made, the formal offer documentation providing further information about any such offer will be made available to you in due course. In the meantime, you do not need to take any action.

Please be aware that addresses, electronic addresses and certain other information provided by you for the receipt of communications from the Company may be provided to an offeror during the offer period as required under Section 4 of Appendix 4 of the Code to allow them to contact you directly in connection with an offer if made.

In accordance with Rule 26.1 of the Code, a copy of this email, the Announcement and copies of all other information, documents and announcements relating to the Possible Offer will remain available during the course of the offer period on the Company's website at <https://delticenergy.com/disclaimer/>. The content of the website referred to in this email is not incorporated into and does not form part of this email.

### **Disclosure requirements of the Takeover Code**

*Under Rule 8.3(a) of the Takeover Code, any person who is interested in 1% or more of any class of relevant securities of an offeree company or of any securities exchange offeror (being any offeror other than an offeror in respect of which it has been announced that its offer is, or is likely to be, solely in cash) must make an Opening Position Disclosure following the commencement of the offer period and, if later, following the announcement in which any securities exchange offeror is first identified. An Opening Position Disclosure must contain details of the person's interests and short positions in, and rights to subscribe for, any relevant securities of each of (i) the offeree company and (ii) any securities exchange offeror(s). An Opening Position Disclosure by a person to whom Rule 8.3(a) applies must be made by no later than 3.30 pm (London time) on the 10th business day following the commencement of the offer period and, if appropriate, by no later than 3.30 pm (London time) on the 10th business day following the announcement in which any securities exchange offeror is first identified. Relevant persons who deal in the relevant securities of the offeree company or of a securities exchange offeror prior to the deadline for making an Opening Position Disclosure must instead make a Dealing Disclosure.*

*Under Rule 8.3(b) of the Takeover Code, any person who is, or becomes, interested in 1% or more of any class of relevant securities of the offeree company or of any securities exchange offeror must make a Dealing Disclosure if the person deals in any relevant securities of the offeree company or of any securities exchange offeror. A Dealing Disclosure must contain details of the dealing concerned and of the person's interests and short positions in, and rights to subscribe for, any relevant securities of each of (i) the offeree company and (ii) any securities exchange offeror(s), save to the extent that these details have previously been disclosed under Rule 8. A Dealing*

*Disclosure by a person to whom Rule 8.3(b) applies must be made by no later than 3.30 pm (London time) on the business day following the date of the relevant dealing.*

*If two or more persons act together pursuant to an agreement or understanding, whether formal or informal, to acquire or control an interest in relevant securities of an offeree company or a securities exchange offeror, they will be deemed to be a single person for the purpose of Rule 8.3.*

*Opening Position Disclosures must also be made by the offeree company and by any offeror and Dealing Disclosures must also be made by the offeree company, by any offeror and by any persons acting in concert with any of them (see Rules 8.1, 8.2 and 8.4).*
